### GENERAL GUIDELINES FOR ALL BUSINESSES & ORGANIZATIONS

- ❑ Designate Workplace Coordinator
- ❑ Ensure safe water source
- ❑ Social Distancing signage & markers
- ❑ Discourage sharing of equipment or tools
- ❑ Encourage paperless systems
- ❑ Employee screenings daily
- ❑ Use electronic conferencing and mail
- ❑ Limit in-person meeting
- ❑ Use teleworking from home where possible
- ❑ Enhanced cleaning protocols
  - EPA approved disinfectant
  - Wipe down common surfaces
- ❑ Encourage contactless pay options
- ❑ Hand sanitizer available throughout
- ❑ Employer provided PPE for all employees
- ❑ No-touch trash bins
- ❑ No congregating in common areas
- ❑ Exclude customers or public exhibiting symptoms
- ❑ Protections for vulnerable employees
- ❑ Adequate air ventilation
- ❑ Emergency plan in place
- ❑ Training for all managers & employees
