

The Summit County Health Department 2024 budget was \$8,915,928. Revenue was comprised of 52% grants/fees and 48% contributions. Contributions include tax dollars & funds donated by partners or individuals. Expenses consisted of 58% wages/benefits and 42% operating expenses.





EPIDEMIOLOGY:

Designed and implemented the Community Health Assessment (CHA) survey. Through marketing and outreach efforts, over **1,700** surveys were completed, aiding efforts to identify the health status and needs of our community, and support current and future public health programming.

HEALTH PROMOTION:

Revitalized Coalville injury prevention with events like Safe Kids Day, a Halloween Health Fair, and Stepping On classes for senior fall prevention. Distributed **448** Narcan doses, and provided **60** car seat education and installation sessions, **33** of which were in Spanish.

ENVIRONMENTAL HEALTH:

Responded to **18** hazmat incidents and completed required site remediation. 2024 inspection included **134** septic systems, **117** percolation tests, **131** swimming pools, **85** mass-gathering events, **345** restaurant permits (permitted annually), and **30** food truck permits. The department also established an air monitoring station in Summit County with the Utah Division of Air Quality.

BEHAVIORAL HEALTH:

Expanded school-based crisis and Medicaid services while supporting unfunded residents. The Substance Abuse Prevention Team hosted prevention classes for **90** high school seniors. Interfaced with **700+** Summit County students, and recruited **24** to the Kamas Youth Coalition. Family movie nights reached **500+** people, and 18 parents participated in parenting programs. Ongoing work to address substance use, suicide prevention, and opioids in Summit County communities, including bilingual services and messaging.



CLINICAL/NURSING:

Our October Vax'n Go Drive-thru clinics in Kamas, Coalville and Park City saw a **163**% increase in vaccine administration this year. In 2023, we administered **470** vaccines and in 2024 we administered **1,238**. These clinics improve access to public health resources for Summit County residents, and ensure equitable and convenient care.

COMMUNICATION & PUBLIC ENGAGEMENT:

Secured a **\$50,000** Rural Health Equity Grant to launch a Spanish language WhatsApp channel and to expand vaccine education and communication channels in Eastern Summit County via text, email, and direct mail. Coordinated outreach events to interface with **700+** ski resort seasonal workers about Health Department resources.



SUSTAINABILITY:

In April, Elektron Solar came online! Elektron supplies clean energy to power almost **100**% of electricity used at Summit County government facilities. Partners include Park City Mountain, Deer Valley, Park City Municipal, Salt Lake City Corporation, Utah Valley University, RMP, and D.E. Shaw Renewables.


WOMEN INFANTS & CHILDREN (WIC):

Summit County WIC transitioned to new cards for remote benefits and honored 50 years of the WIC program with a 38-year staff member. In 2023, WIC had 329 participants and in 2024, the division witnessed a **31**% increase to **431** participants. We are happy to assist our most vulnerable families with nutritious foods and healthy habits.



EARLY INTERVENTION (EI):

Served **100+** children and piloted a successful Augmentative and Alternative Communication Program with our non-verbal children. Strengthened our network with community partners to assist with resources to families. Selected to participate in the federal audit with the Office of Special Ed.





PUBLIC HEALTH EMERGENCY PREPAREDNESS:

Initiated the NACCHO Project Public Health Readiness accreditation, expanded emergency preparedness through training and community programs, and participated in the Summit County Full-Scale Exercise to test emergency plans, operations, and communication for disaster response.
